1.	The Agent/Broker may solicit and submit applications for loan, funding or classes of Insurance for which a commission shall be paid.								
2.	The Agent/Broker is authorized to refer potential clients to us in need of project finance.								
3.	The Agent/Broker is an independent contractor, not an employee of the Company which shall have right within the authority granted.								
4.	The Agent/Broker are not authorized to issue any funds or policies, unless first signed by the company.								
5.	If fees are charged, either by the Company or by the Agent/Broker or Both, the Agent/Broker must comply with all funding regulations.								
					Duties				
1.	The Agent/B	The Agent/Broker shall comply with all the rules and regulations of the Company.							
2.	The Agent/Broker must immediately notify the Company if the Broker/ Agent have any knowledge of a possible claim in accordance with the Rome Italy Unfair Claims Practices regulations.								
3.	Any unused Company supplies furnished by the Company to the Agent/Broker shall always remain property of the Company.								
4.	•	The Agent/Broker shall be compensated with 1% of the total loan amount requested by his/her clients which will be transferred into his/her account once all formalities have been concluded.							





- 5. In the event the Company shall either during the continuance of this Agreement or after its termination, refund under any policy funds by reason of cancellation or otherwise, the Agent/Broker shall immediately return to the Company the commission retained by him on the portion of returned loan disbursed. All accounting records of the Agent/Broker pertaining to business of the Company shall be subject to inspection at any time by an accredited Company representative.
- 6. It is Agent/Broker's responsibility to ensure due diligence on his/her client is complete so as not to hold the company harmless and to defend the Company in all matters relating to the client's funding.
- The Agent/Broker will, during continuance of this Agreement or after its termination, remit all company properties collected. 7.
- The Agent/Broker agrees to non-circumvent the Company on any accounts submitted to the Company for placement by use of a 8 Agent/Broker of Record letter or any other means and not seek direct appointment.

Agent/Broker Representation Fee Payment,

The Agent/Broker will be paid or will receive their payment once the transaction is completed with their client and funds will be disbursed to both client and Agent/Broker at the same time.

Termination

- 1. Either party may terminate this agreement at any time upon written notice to the other.
- The Agent/Broker's authority under this agreement shall only be effective during such times as the Agent/Broker is duly licensed 2. according to law. Agents must be appointed to receive commission.

Conditions

- All documents shall remain property of the Company and shall be returned to the Company on demand or upon termination of this 1 Agreement. All such documents shall be returned to the Company within ten (10) working days
- This Agreement supersedes all previous agreements whether written or oral between the Company and the Agent/Broker and shall be 2. effective on the date it is signed and shall remain in full force and effect until it is suspended, superseded or terminated as provided herein.
